### Item #1 – Meeting Call to Order

Mayor Partington called the meeting to order at 7:00 p.m.

### Item #2 – Invocation

Pastor Scott Smith, First United Methodist Church of Ormond Beach, gave the invocation.

### Item #3 – Pledge of Allegiance

Mayor Partington led the Pledge of Allegiance.

### Item #4 – Audience Remarks

Mr. Jerry Orzel, 137 Rosewood Avenue, discussed the former church building located at 56 North Beach Street. He requested the Commission retract their previous vote to demolish the building on the property. He discussed reasons why he believed the building should be saved and requested the Commission provide the community with an opportunity to provide input on the future of the site.

Ms. Julia Truilo, 307 John Anderson Drive, Ormond MainStreet (MainStreet) Director, requested the Commission reconsider their vote to demolish the former church building at 56 North Beach Street and listed reasons to support her request.

Ms. Judith Stein, 166 Orchard Lane, stated she was a board member on the Ormond Beach MainStreet Board and President of the Ormond Beach Arts District. She noted both organizations were requesting the city pause demolition of the building at 56 North Beach Street. She discussed her support for delaying the demolition and the importance of allowing interested parties the opportunity to investigate potential options for the building.

Mr. Bill Jones, 8 Twelve Oak Trail, stated he believed the decision to demolish the building was the correct decision. He discussed the poor condition of the structure and the costs that would be needed to fix the building. He discussed various options that had been suggested for the site in the future and reiterated his support.

Mr. Ted Brown, 3 Havenwood Trail, discussed development that was proposed to take place on the former golf course located in the Tomoka Oaks subdivision. He listed potential negative impacts he believed the development would have on the site and surrounding area.

Ms. Missy Herrero, 111 North Saint Andrews Drive, stated she was a resident of Tomoka Oaks and discussed the neighborhood and area in further detail. She noted her disapproval of the development proposed to take place on the former golf course and discussed land preservation. She requested the Commission utilize resources to support any funding sources available to purchase a portion of the former Tomoka Oaks golf course.

Ms. Ashley DuFrene, 118 North Saint Andrews Drive, discussed a petition that was signed regarding preserving land that is part of the Tomoka Oaks former golf course. She provided statements and comments from various Ormond Beach residents that signed the petition in support of saving the green space.

Ms. Beth King, 40 North Saint Andrews Drive, discussed the former golf course and history regarding the site. She noted the negative impacts that would come from developing the site and requested the city devote economic development resources to identify possible ways to preserve the property.

Ms. Mary Greenlees, 94 North Saint Andrews Drive, thanked the Commissioners for their service to the community. She discussed the proposed development in Tomoka Oaks and her concerns regarding the development. She requested the city explore possibilities and potential options of saving the green space.

Ms. Peggy Brown, 112 North Saint Andrews Drive, noted those who purchased their homes in Tomoka Oaks on the golf course had the expectation that they would always be on a golf course, or have open space behind their homes. She proceeded to discuss the company that purchased the golf course and was proposing to develop the site. She provided the Commission with a copy of the warranty deed for the site.

Ms. Susan Klippel, 303 Rio Pinar Drive, discussed memories she had at her home in Tomoka Oaks watching the sunrise over the former golf course property with her husband. She noted she could not imagine the property becoming developed.

Mr. Tom Fitzgibbon, 51 South Saint Andrews Drive, discussed Ormond Beach and the proposed development in Tomoka Oaks. He noted the potential traffic impacts that may occur and requested the Commission keep those impacts in mind. He stated he would love to see a public golf course open in Ormond Beach.

Ms. Linda Williams, 131 Bosarvey Drive, stated she was representing her group, Civil Discourse Part 2: Common Ground, and discussed the importance of coming together to hear everyone's ideas and thoughts. She discussed her group and the importance of synergy.

Mr. Jim Schultz, 117 Harvard Drive, discussed censorship and articles that were written regarding COVID-19.

Item #5– Approval of Minutes

Mayor Partington advised the minutes of the May 4, 2021, meeting had been sent to the Commission for review and were posted on the city's website for public viewing. He asked for any corrections, additions, or omissions.

**Commissioner Persis moved, seconded by Commissioner Littleton, for approval of the May 4, 2021, City Commission meeting minutes.**

Item #6D – Local Option Fuel Tax Distribution Formula

Acting City Clerk Wendy Hontz read by title only:

RESOLUTION NO. 2021-87  
A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF  
AN INTERLOCAL AGREEMENT FOR THE DISTRIBUTION OF

**Commissioner Persis moved, seconded by Commissioner Littleton, for approval of Resolution No. 2021-87, as read by title only.**

Commissioner Kent stated he felt the agreement between Volusia County and the City of Ormond Beach did not result in a good deal for the residents of Ormond Beach. He noted Ormond Beach's fuel tax was one of the highest in the state. He stated the staff report explained that the percentage would stay the same, but the methodology on calculating the fuel tax would result in a revenue loss of \$230,000 for Ormond Beach. He noted it appeared the City of Ormond Beach would get less and Volusia County would receive more. He questioned if that statement was accurate; whereby, Ms. Shanahan stated it was not, but explained the city would be taking a financial loss.

Commissioner Kent noted city managers throughout Volusia County had been meeting regarding the local option fuel tax for three years. He reiterated the agreement resulted in less money for Ormond Beach.

Ms. Shanahan discussed the local option fuel tax and the impacts it had on Ormond Beach, as well as other cities located within Volusia County.

Commissioner Kent questioned if Volusia County was gaining additional funds from the agreement; whereby, Ms. Kelly McGuire, Finance Director, noted Volusia County would be receiving the same percentage they previously had.

Ms. McGuire noted the agreement was not a beneficial deal for the City of Ormond Beach, and discussed financial losses that the city would take over the upcoming years.

Commissioner Selby discussed the local option fuel tax agreement. He noted electric vehicles did not pay gas taxes and questioned if there was any discussion on taxing electric vehicles; whereby, Ms. Shanahan noted there had been discussion, but no action had taken place.

Commissioner Littleton stated Ms. Shanahan had been working diligently over the past few years on the agreement and explained he would be voting in favor of the item for that reason.

Commissioner Persis noted she agreed with Commissioner Littleton and had total faith in Ms. Shanahan to recommend the right choice for the city.

Mayor Partington questioned what would happen if the item were not approved; whereby, Ms. Shanahan stated she was unsure.

Ms. McGuire noted she did not know the specific answer either, but discussed the agreement and prior agreements regarding the local fuel tax in detail. She noted other cities within Volusia County would be getting less funds in addition to the City of Ormond Beach. She explained the agreement was based on a majority vote. She stated if the majority of the cities did not pass the agreement it would go to a default formula, but explained that was unlikely to happen.

Ms. Shanahan stated Volusia County would need an interlocal agreement in order to provide the funds to the city.

Ms. McGuire stated the city received the funds directly from the state. She discussed the process that would take place once the agreements were approved or denied.

Commissioner Persis questioned if the city would save money by voting against the item; whereby, Ms. McGuire stated it was unlikely.

Commissioner Kent noted Ms. Shanahan and Ms. McGuire did the best job they could on the agreement. He noted the agreement was not fair to Ormond Beach and stated he would be voting against the item and discussed reasons why.

Mayor Partington stated he would also be voting against the item. He noted despite Ms. Shanahan's best efforts, he was not pleased with the outcome of the agreement.

Commissioner Selby questioned what would happen if the Commission voted against the item; whereby, Mr. Randy Hayes, City Attorney, stated voting down the agreement would show that the city was not a participating party to the agreement.

Mr. Hayes discussed the agreement and terms in further detail. He noted the agreement would fail if a majority of the municipalities voted against it, which he explained was unlikely to happen. He stated he was not familiar enough with the agreement to give an exact answer as to what would happen if the city denied the agreement, but discussed his opinion on potential outcomes.

Commissioner Persis questioned what would happen if the City of Ormond Beach was not a participating party to the agreement; whereby, Mr. Hayes stated he did not have an answer to the question at the current time, but provided examples of what may happen if a majority of the cities did not approve of the agreement.

Mr. Hayes noted the agreement did not clearly address what would happen if a city did not approve of the agreement. He stated staff could investigate the issue and provide the Commission with further direction. He explained Volusia County was seeking to have the agreement approved on or before August 31, 2021, noting there was time to look into the agreement further.

Item #6F – Volusia County Joint Participation Agreement (JPA) - N. Beach Street Radar Feedback Signs

**Commissioner Persis moved, seconded by Commissioner Littleton, for approval of Resolution No. 2021-89, as read by title only.**

Commissioner Selby stated he drove North Beach Street routinely and did not believe there was a speeding issue on the street, but instead felt that many drivers drove under the speed limit. He stated Volusia County had made the street a no-passing zone and drivers were unable to pass other vehicles. He felt the radar feedback signs were unnecessary and did not recall any citizens reaching out to him regarding speeding in the area. He stated he would be voting against the item.

Commissioner Persis inquired if the Ormond Beach Police Department were aware of speeding issues on North Beach Street; whereby, Chief Jesse Godfrey, Ormond Beach Police Department Chief of Police, stated there was an individual who lived on North Beach Street who frequently called in complaining about speeders.

Commissioner Persis inquired if many tickets were issued on the street; whereby, Chief Godfrey noted he did not have the information to answer the question at the current time.

Commissioner Kent noted Volusia County was willing to partner with the City of Ormond Beach on radar feedback signs, but not partner with the city on the local gas tax rates. He noted when reading through the packet, he questioned why North Beach Street was chosen as the location for the signage. He stated he would not be voting against the item, but expressed his opinion that other streets in the city may have more speeding issues.

Mr. Shawn Finley, City Engineer, noted the city was approached by Volusia County regarding the radar feedback signs. He noted that Beach Street was a Volusia County road and discussed the proposed locations for the radar feedback signs. He stated city staff believed the signs would be a good-faith effort to help reduce speeders for

residents who live on North Beach Street. He stated city staff felt the partnership was a good opportunity.

Commissioner Selby questioned if the road was exempt from the city's traffic calming ordinance; whereby, Mr. Finley stated it was.

Commissioner Selby inquired if Volusia County would still move forward with the project if the city did not agree to the partnership; whereby, Mr. Finley stated he believed Volusia County would not continue with the project and proceeded to discuss the project in further detail.

Commissioner Selby noted Volusia County requested half of the \$25,000 expenditure, which he felt was a feel-good action. He reiterated he would be voting against the item and felt there was not a speeding issue on that road.

Commissioner Littleton discussed other radar feedback signs located within the city. He noted since the proposed signage was located in Commissioner Selby's zone, he would be taking his comments into consideration and also be voting against the item.

He stated he was glad to see the item passed and discussed the agreement in further detail, but noted he was disappointed the agreement was a sole source agreement.

Commissioner Selby questioned if the item went out for bid; whereby, Ms. Joyce Shanahan, City Manager, explained the item was advertised on DemandStar and was published for a week to solicit proposals, but noted the city did not receive any proposals.

Commissioner Selby stated he was disappointed on the timing of the agreement as well. He stated when the consultant was finished with the final report they were scheduled to provide the final report to staff, noting he wished the consultant would provide the final report to the Commission instead. He discussed the report in further detail and the information it would provide. He stated he was glad the item passed, but reiterated his reservations.

Mr. Spraker stated the item was a request to allow geometric patterns on the façade of the Publix building under development at 101 East Granada Boulevard. He noted geometric patterns could not be approved by city staff, and instead needed City Commission approval. He reviewed a PowerPoint Presentation that displayed images of the requested geometric pattern. He stated the Ormond Beach MainStreet Design Committee and Board recommended approval, and staff recommended approval as well.

Commissioner Selby questioned if the geometric patterns would be displayed across the entire front façade; whereby, Mr. Spraker stated the focus appeared to be more on one side of the building and reviewed the proposed plans in further detail.

**Commissioner Persis moved, seconded by Commissioner Selby, for approval of Resolution No. 2021-91, as read by title only.**

Commissioner Kent discussed the history of the site and various businesses that had been established at the building location in the past. He stated he was glad to see that Publix was coming to the site. He noted he was pleased that the use of geometric patterns had to come before the Commission for approval. He noted the proposed patterns were esthetically pleasing and helped improve the appearance of the building.

Commissioner Littleton and Mayor Partington thanked Mr. Joe Daniels for inviting the Commission to celebrate the history of the African-American community within the city and complimented the event that was held.

Project Updates

Ms. Shanahan provided updates on the following projects taking place in the city: MacDonald House Improvements, Florence Street On-Street Parking, U.S. Highway One forcemain and watermain projects, Adaptive Signalization project, and the South Ormond Neighborhood Gym Expansion.

Compliments and Congratulations

Ms. Claire Whitley, Assistant City Manager, discussed the Unity Tour that Chief Godfrey and Ormond Beach Police Department Sergeant Willis had participated in.

Ms. Whitley noted Chief Godfrey had recently celebrated his 10-year anniversary with the city and congratulated him on his achievement.

Commissioner Kent, Commissioner Persis, Commissioner Littleton, Commissioner Selby, and Mayor Partington complimented and congratulated Chief Godfrey for his dedication to the city and hard work.

Commissioner Kent and Commissioner Persis complimented Fire Chief Rusty Sievers and thanked him for his service.

Commissioner Kent complimented Ms. Shanahan and thanked her for dedication and hard work.

South Arbor Drive

Commissioner Kent noted the residents who lived on South Arbor Drive were under the impression that they would be receiving work in the spring to help assist with flooding issues in the area. He requested staff reach out to the residents to communicate with them on the process and provide an updated timeline.

Mayor Partington complimented the Ormond Beach Fire Department and Ormond Beach Police Department. He noted the city needed to discuss and review reports regarding a new Emergency Operation Center that could also be utilized as a training facility. He discussed the importance of having a premier location for first responders during natural disasters.
